Introduction:

Summer rates are assessed by residency, level of course (<5000 is undergraduate), and delivery format. Main Campus programs that are delivered primarily online (Web Based 100%, Web Based Majority 90-99%, and Web Based Hybrid 50-89%) are charged the Appstate Online tuition and fee rates with an additional book rental fee assessed. See page 3 below.

During Summer Terms, due to the condensed timeframe, **the last day to reduce your schedule and be eligible for a refund is 11:59pm on the 2nd day of classes for each session.** This applies regardless of meeting day and times or if classes have met yet.

Detail of Summer Fees

Student Activity Fees - The Student Activity Fee funds the summer term operating expenses for Counseling and Psychological Services, Career Development Center, University Recreation, and the Plemmons Student Union.

Education & Technology Fee - The Education and Technology Fee is used to supplement state budget allocations with regard to student technology needs. This includes needs directly associated with classroom and laboratory instruction including student computing labs, educational supplies and materials used for instructional purposes, network infrastructure, central email and internet services and the cost of building modifications associated with the enhancement of classroom or lab space.

Safety & Security Fee - This fee provides funding for several of the recommendations made by the UNC Board of Governors' 2013-14 UNC [system-wide] Campus Security Initiative report which include, but are not limited to, (1) campus police officer and tele communicator compensation; (2) highly qualified and trained investigators and hearing officers for reports of serious offenses, such as sexual violence; (3) Title IX and Clery Act compliance coordination; (4) substance abuse counselors, case managers, and/or other counseling staff; and (5) system-level safety and security training, coordination, and audit functions.

Health Services Access Fee - The Health Services Fee funds the operating expenses of the Student Health Service Center and allows access for students to the center.

SGA Fee - This fee supports UNC system-level organization that champion the concerns of students and ensures the affordability and accessibility to quality education today and tomorrow.

Book Rental Fee - This fee supports the bookstore book rental program. Students do have an option to opt-out of this fee. Students should either contact the bookstore for more information or see [The Book Rental Program Website](#).
