Summer Tuition and Fee Rates for the Boone Campus Programs are approved by the UNC System President. Some Miscellaneous Fees that are approved by the University Chancellor may be tentative at the time of publication of this document.

Summer Tuition and Fee Rates for Appstate Online Programs

Boone Campus Rates are approved by the UNC President. Appstate Online Rates are the same as the preceding Fall and Spring with the exception of any Chancellor Approved Fees. Appstate Online summer rates are found on page 5 of this document.

Additional Information

Although the General Assembly provides for most of the instructional costs of institutions through state appropriations, institutions generally rely entirely on student fees to finance activities, services, and some facilities that enhance the overall student experience. These fees are considered part of the cost of enrollment in a program and do not reflect the provision of any specific service. Fees are assessed based on the program the student is enrolled in as well as student level (undergraduate or graduate). Miscellaneous Fees are approved by the Appalachian State University Chancellor. Some Miscellaneous fees may not be fully approved at the time of the creation of this Tuition and Fee Schedule.

AppState Online Programs: Students who are enrolled in a program designated as an AppState Online Program will be assessed fees at the AppState Online Program rates. The majority of these rates are approved with the Fall/Spring Rates that were in effect the prior Fall/Spring terms. These fees are charged pursuant to considerations surrounding the functionality of online programs. This also includes AppState Online Programs that meet at an offsite location. Online programs may not provide access to all campus services and facilities. Students enrolled in an App state Online program may contact the Office of Student Accounts if the student wishes to opt-in to the Health Services Access Fee. If a student opts in, the full-time rate will be charged regardless of the number of hours that the student is enrolled. If a student is enrolled in an App state Online program, all courses will be assessed at the AppState Online fee schedule.

Boone Campus Programs Program based fees are required for students enrolled in a program, designated for the Boone campus, regardless of participation in or use of program-based services or facilities. The only exception to these required fees is that a student may opt-out of the book rental fee. Please contact the campus bookstore for opt-out deadlines and to request to opt-out. If a student is enrolled in a Boone campus program, all courses will be assessed at the Boone campus program fee schedule.

If you have questions regarding which fee structure applies to your program, please consult your advisor or the Registrar's Office (for undergraduate) and Graduate Studies (for all other levels). Once tuition and fees are charged, the Office of Student Accounts can assist with explanation of the charges. We cannot answer questions related to why a specific program is designated as either AppState Online or Boone/Hickory campus program fees.
