**Main Campus Courses:** Main Campus courses are primarily on our main campus in Boone, NC; however, some programs do offer online courses that are categorized as main campus and are thus charged Main Campus rates as approved by the UNC Board of Governors.

# Description and use of Fees

**Tuition** - Tuition is composed of two components Campus Based Tuition and Regular Tuition. All tuition is submitted to and approved by the UNC Board of Governors.

**Health Service Fee** - The Health Services Fee funds the operating expenses of the Student Health Service Center.

**SGA Fee** - This fee supports UNC system-level organization that champion the concerns of students and ensures the affordability and accessibility to quality education today and tomorrow.

**Education & Technology Fee** - The Education and Technology fee helps fund upgrades for classroom equipment, equipment needs for Information Technology Services, computer labs and instructional labs.

**Athletic Operations Fee** - This fee provides operating support for the university's athletic department and programs. The marching band fee of \$5 is also included here. This provides support for equipment and uniform purchases.

## Student Activity Fees

**Educational, Recreational and Renewable Energy Initiative** - The Educational and Recreational Fee funds activities for a variety of student activities such as the Student Government Association, student publications, multicultural student development and education, organizational leadership education, university recreation and other student services. The renewable energy projects recommended by the renewable energy initiative committee.

**Cultural Affairs Fee**- helps fund the Performing Arts Series, the Visual Arts Center, and Auditorium Technical Services.

**The Student Union Fee** - funds the operating expenses for the Student Union.

**Campus Security Fee** - This fee provides funding for several of the recommendations made by the UNC Board of Governors' 2013-14 UNC [system-wide] Campus Security Initiative report which include, but are not limited to, (1) campus police officer and telecommunicator compensation; (2) highly qualified and trained investigators and hearing officers for reports of serious offenses, such as sexual violence; (3) Title IX and Clery Act compliance coordination; (4) substance abuse counselors, case managers, and/or other counseling staff; and (5) system-level safety and security training, coordination, and audit functions.



## **Retirement of Debt**

**Athletics Facilities** - This fee supports the debt service for the athletics facilities enhancement project. This project included the women's softball field, replacement of the synthetic playing surface on the football field, an upgrade of the track and field facilities at Kidd Brewer Stadium and construction of a new field house to provide expanded and upgraded training, meeting, office, and support facilities.

**Dining Facility** - This fee supports the debt service for the Central Dining Hall. The Central Dining Hall is home to both Rivers Street Cafe and Sanford Commons.

**Student Recreation Center** - This fee supports the debt service for the student recreation center. It includes a swimming pool, weight training and exercise rooms, basketball courts, a climbing wall, a jogging track, a sports club, gym and space for the Office of Outdoor Programs.

**Student Union Addition** - The student union addition project is for additional facilities needed in the Plemmons Student Union to offer value-added experiential and academic learning experiences to high-achieving Appalachian students. Five existing Academic Affairs and Student Development departments will be co-located in the addition to provide collaborative opportunities in a highly visible and easily accessible central campus location.

**Leadership Annex** - This fee funds the debt service for the construction of an 18,202 square foot building devoted to student leadership programs.

**Infrastructure Improvements** - This fee supports the debt service for renovations to existing academic space needed for classrooms to handle recent growth.

**Sanford Hall** - This fee supports the debt service for ongoing renovations.

**Transportation Fee** - This fee provides support for the Appalcart transportation system and also for Mountaineer Safe Ride.

**Intern/Practicum Fee** - This fee is to cover liability insurance for students participating in designated courses that contain curriculum that based on the Office of General Counsel, require liability insurance coverage.
